

Minute of the Meeting of Cameron Community Council Wednesday 17 March 2021 at 6.30 pm Online Meeting via Zoom (due to Covid-19 restrictions)

Note: As members of the public had been notified (in *The Citizen* and on the CCC website) that they could join this Zoom meeting, it was a formally constituted meeting of Cameron Community Council

- 1 Presentation from Doug Stephen, Friends of Craigtoun, planned for April meeting
- **2 Presentation**: William Stewart, Owner, Stewart's Resort.

Mr Stewart provided information about the current planning application 20/02716/FULL for 49 retirement caravans (noting the number had recently been reduced from 49 to 47). He stated the intention was to offer the retirement caravans only to those over 50-55. Mr Stewart confirmed the large underground sewage tanks being installed for the 82-lodge leisure park would also service this development, as a stopgap to a permanent solution when Scottish Water provides mains drainage to the area. Mr Stewart confirmed the application included screening and landscaping plans for the site. Mr Stewart noted his intention to make the visitor hub facilities open to the community, and extended a general invitation to CCC members to visit the site when covid restrictions permitted.

- a. Matters arising from minutes of previous meeting:
 - North Bank lodge development: No further update
 - 20/02716/FULL, Siting of 49 retirement caravans including landscaping and associated infrastructure (amendment to 15/00727/ARC), North Bank Farm, Lathockar. See 'Presentation' above.

- 20/02329/FULL, Erection of extension to existing holiday park hub to form swimming pool, North Bank Farm, Lathockar: CCC's Consultee Comment had been submitted to FC (Attachment 2).

- c. 20/00952/PPP, Erection of five dwelling houses with associated access and parking, land to east of Braehead Cottage, Peat Inn. It was noted that this application, refused in December 2020, had been referred to FC's Review Panel in March 2021. The Secretary confirmed that CCC's original objection comment would also be forwarded to the Panel.
- d. The Secretary reported a request for a meeting had been received from Orbit Communications acting on behalf of GPH Engineering, which has acquired land at Feddinch and intends shortly to submit a Proposal of Application Notice in respect of a golf clubhouse and other facilities. It was agreed Secretary to contact Orbit and request more information before a proposed meeting.
