



This is a chance to have your say on the way Cameron develops.

Local Place Plans (LPPs) are completed by community groups, usually a Community Council, to reflect the majority of wishes of a community in regard to issues such as;

- Planning, e.g. areas zoned for future development and for what reason
- Transport, e.g. public transport provision, walking and cycling provision
- Roads, e.g. potholes, speeding/speed limits, traffic calming, gritting
- Education provision e.g. nursery/primary/ secondary schools
- Health facilities
- Council services, e.g. bin/recycling, play parks, libraries
- Any other issue you may think relevant

Councils have a statutory responsibility to take LPPs into account when completing Local Development Plans so it is very important that an area has a LLP, especially where planning is concerned. If no LLP is in place then developers can push for an area to be 'zoned' for development, whereas if a community has exhibited, via a LLP, that there was no support for development then than has to be taken into account.

The Fife Council submission deadline for LLPs is the end of January 2024 (the submission deadline is the date by which FC can be sure they will be in time to fully inform the preparation of the next Local Development Plan).

Elections for Community Councils are due to take place across Fife in September 2023 and as the January 2024 deadline would be very short for the new Cameron CC committee to promote, receive, collate and prepare a LLP, the current committee are looking to promote, receive, quality check and collate the responses so that they are ready for the new committee to prepare a LLP for Fife Council prior to the January 24 deadline.

Please list your comments in the order of these headings;

Planning

e.g. areas zoned for future development and for what reason

Transport

e.g. public transport provision, walking and cycling provision

Roads

e.g. potholes, speeding/speed limits, traffic calming, gritting

Education provision

e.g. nursery/primary/secondary schools

- Health facilities
- Council services

e.g. bin/recycling, play parks, libraries

• Any other issue you may think relevant
